A rabbit ate my dirt

Crows were drinking cawfee and playing crowquet as turtle doves (mourning doves) were whistling wings on a utility wire. Time wings by and summer picks up speed. I hear insect noise at night. Cricket music. Kobayashi Issa wrote, "Summer night—even the stars are whispering to each other." The Dog Days of summer last from July 3 to August 11. This period of sweltering weather coincides with the year's heliacal (at sunrise) rising of Sirius, the Dog Star. Don't worry about your lawn. Grass endures.

Killdeer are drama queens. One looks as if it had a broken wing and calls loudly as if in pain. It's all a big act by the killdeer parent, putting on a show as it tries to lure you away from its nest.

I look out the window at a stunning bird and feel as if I'm on the outside looking in. In the dooryard, our planted mint attracts dumbledore, an old English word meaning bumblebee.

I listened to Neil Young sing, "Beautiful Bluebird." Young bluebirds have been scarce this year, but blue jay, oriole and grosbeak fledg-

lings entertain as they explore their new world. The day was a baby when I put peanuts in the shell in a feeder. A young blue jay had never seen such things. He tried to land on the feeder 15 times. I counted them. None involved a successful landing. He found the peanuts vexing. An adult flew in, grabbed a shell and flew away. The youngster followed suit, but not without trepidation and several fumbled goober footballs.

Tall vellow flowers bloom: common mullein, evening primrose and Black-eyed Susan. White and yellow clovers prosper on roadsides. Canada thistle is allelopathic, which

means it secrets chemicals from its roots that are toxic to surrounding plants. Canada thistle and bull thistle both have spiked leaves. Bull thistle stems have spiny wings that are absent on Canada thistle. The spines along its stem make a bull thistle look meaner than a Canada thistle. Both have pink/purple/ reddish flowers, but bull thistles have much larger flowers.

Monarch butterflies land upon swamp milkweed, common milkweed and butterfly weed in our yard. Generations 3 and 4 monarchs are the great- and great-greatgrandchildren of the overwintering monarchs. Eggs laid from late May through July (Generation 3) and late June through August (Generation 4) congregate in large numbers in September, and by the end of October have left in a migration to their winter grounds in Mexico.

We'll start seeing more flocks of birds. A flock provides safety in numbers and keeps an eye on everything, especially you. It's like circling the wagons of a wagon train for protection.

Breeding Bird Survey (BBS)

I did a BBS covering parts of Freeborn, Mower and Steele counties in June. I've done that count for umpteen years and each year, it's fun with a proper amount of uncertainty. It's an exercise that feeds my constant curiosity. I make 50 designated stops and count any bird I see or hear in 3 minutes according to my egg timer. I begin at 5:02 a.m. sharp and in the morning's clarity, see wild critters besides birds—fox, raccoon and skunk. Bald eagles have become expected, as have trumpeter swans, Eurasian collared-doves and red-headed woodpeckers. I saw a couple of yellow-headed blackbirds. They've been scarce in that area this year. I was pleased to count a chimney swift flying above a red barn on a farm, yellow-billed cuckoo, Virginia rail, green heron and claycolored sparrow. I was happy to get a long look at a gray (Hungarian) partridge on the road. I notice absences. Not one Savannah sparrow, grasshopper sparrow or eastern bluebird.

Q&A

"Do fish rot from the head down?" Despite the ancient proverb stating this, the guts of fish rot and stink before the head.

"Minnesota doesn't get periodical cicadas, but does Iowa?" Yes, they get Broods III, IV and XIII of the 17-year cicadas and Brood XIX of the 13-



year cicada.

"I watched a rabbit eat dirt. Why was it doing that?" The practice of eating dirt, especially claylike soils, is called geophagia. A common explanation as to why animals and people eat dirt is that soil contains minerals, such as calcium, sodium and iron, which support vital biological

processes.

"Do pheasants lay eggs in the nests of other species?" They are rare nest parasites on grouse and ground-nesting waterfowl.

What is the smallest bird in the U.S.?" The calliope hummingbird is the smallest native bird in North America.

Rode Family recognized as a 2021 U of M Farm Family

The Rode family of Welcome has been named Martin County's "2021 Farm Family of the Year" by the University of Minnesota.

The Rode family farm was purchased by Wendell's mother and father, Rudolph and Clarena, in 1958. Wendell grew up helping with the farming operation that included livestock, grain farming, laying hens, and a dairy herd. After Wendell and Helen were married in 1972, the couple began their own farming business. They eventually purchased the family farm in 1982 where the couple continued to farm until their retirement in 2018.

The farm remains in the family today. The Rodes' daughter and son-in-law, Leah and David Mulder, have purchased the acreage portion while the tillable land is rented out. The Rodes have set aside a small parcel for participation in CREP. Throughout the years, the family has

offered acres for research and test plots for local seed companies.

The Rodes raised their daughter, Leah, their son, Brian, and niece, Kendra, on the farm and shared in their involvement in Martin County West FFA. In later years, Leah, Brian, Kendra and their families continued to help with fall harvest and other chores.

Wendell has been involved in numerous community and agriculture organizations and served 12 years as district supervisor on the Martin County Soil and Water Conservation District. He also served on the Minnesota Association of Resource Conservation and Development Council. He was a charter member of the Welcome Jaycees and Welcome Lions Club and is a lifetime member of the Fox Lake Conservation Club. Wendell is president of the Welcome Historical Society.

Helen is very active in the community having served on the STEP and Martin County Historical Society Board. Helen also developed and coordinated the Martin County Mentoring Network for area youth. The network was a collaboration between University of Minnesota Extension and Martin County that received a statewide county achievement award.

The families will be officially recognized in a ceremony Thursday, Aug. 5 at the annual Farmfest near Redwood Falls. Profiles of the 2021 honorees and information on the recognition event can be found on the University's farm family website, https://z.umn.edu/farmfamilies-year.

Honored families are chosen, one per county, by local University of Minnesota Extension committees based on their demonstrated commitment to their communities and to enhancing and supporting agriculture.

"These farm families

are a major driver of Minnesota's economy and the vitality of Minnesota's rural communities," said Bev Durgan, dean of University of Minnesota Extension. "The University of Minnesota is proud to recognize these farm families for their contributions to agriculture and their communities."

Along with Farmfest, University units sponsoring the recognition event include University of Minnesota Extension, Minnesota Agricultural Experiment Station, the College of Food, Agricultural and Natural Resource Sciences and the College of Veterinary Medicine.

Fox Lake League receives \$200,00 loan

From power plant to local park Federated's Revolving Loan Fund assists Fox Lake Conservation League

Federated Rural Electric assisted the Fox Lake Conservation League, Sheburn, (FLCL) with a \$200,000 Revolving Loan Fund. The Conservation League bought 44 acres of land that was formerly the Alliant power plant on the south side of Fox Lake to develop the area into a park for the general public.

Federated and the League signed the 10-year loan paperwork on July 13 and the organization closed on the property July 19. As funds are repaid, they can be loaned to other organizations.

The Fox Lake Conservation League was formed in 1947 for the purpose of preservation of natural resources, fish, wildlife in Martin County. "Our main goal with this purchase is to protect thousands of feet of shoreline from private development and ensure the property is open to the public," said Jim Miller, treasurer of the Fox Lake Conservation League. "We have no solid plans, but anticipate a seasonal site campground, public boat access, handicap-available fishing pier, winter fishing access, walking paths and a pollinator plot are among ideas in the works. I estimate it will take two to three years before a final plan is in place and fundraising begins."

"Federated initially applied for the zero-interest loan and then charges up to one-percent handling to the organizations," stated Scott Reimer, Federated's general manager. "As these organizations pay back their loans, this money

goes into a revolving loan fund to assist other organizations for economic development or community facilities." The recipient also pays for the loan's closing costs and one percent interest.

Federated has a long history of economic development. Since 1992, Federated provided economic development dollars totaling \$3.8 million. This contributed to keeping 1,086 jobs and securing 448 jobs in the area. More specifically, Federated's revolving loan started in 2009 with a loan from the United States Department of Agriculture (USDA) for \$244,000 that financed a Ceylon fire truck and Tenhassen Township Hall. Then in 2016 Federated secured additional USDA revolving loan funds and added a matching 20 percent totaling \$421,515 toward new Heron Lake and Round Lake Fire Trucks. Since then Okabena has used the revolving loan funds for its fire department brush fire truck.

Over the past four years, USDA Rural Development has invested nearly \$2.9 million in REDLG funding to support community facilities and small business development and expansion in rural communities throughout Minnesota. Rural Development also invests in housing, water and wastewater treatment, community facilities, renwable energy and broadband. Ag Update: JULY 12 WASDE REPORT MOSTLY NUETRAL

s expected, the USDA World Supply and Demand (WASDE) Report released on July 12 included increased corn acreage and the expected 2021 corn production, compared to the June WASDE Report; however, some of the added corn supply for was accounted for by a slight increase in projected total corn usage for 2021-22. The grain prices have been mixed since the release of the WASDE report. Corn and soybean prices had been quite "bullish" immediately following the release of the USDA 2020 Crop Acreage Report on June 30, which indicated less corn and soybean acres than most grain marketing analysts expected. USDA estimated the 2020 corn acreage at 92.7 million acres, which was up by 1.6 million acres from the planting intentions on March 1.

Based on the July 12 WASDE report, USDA is projecting that 2021-22 corn ending stocks will be 1.43 billion bushels by August 31, 2022, which is a slight increase of 75 million bushels in the carryover level in the mid-June WASDE report. The estimated corn ending stocks for 2020-21 is 1.08 billion bushels, which was nearly the same as the June estimate. The 2021-22 carryover level is based on June 30th estimate of 92.7 million planted corn acres and 84.5 million harvested acres in the U.S. in 2021, with an average U.S. corn yield at the record level of 179.5

bushels per acre. This resulted in an estimated 2021 total corn production of 15.16 billion bushels, which was up by 175 million bushels from the June report. The 2021 total U.S. corn production compares to 14.2 billion bushels in 2020, 13.6 billion bushels in 2019, 14.3 billion bushels in 2018 and 14.4 billion bushels in 2017. The total corn usage for 2021-22 is estimated at just over 14.8 billion bushels, which would be slightly lower than the estimated total corn usage of just over 15 billion bushels for 2019-20.

USDA is now projecting 2021-22 market year average (MYA) corn price at \$5.60 per bushel, which is a decrease of \$.10 per bushel from the June WASDE report. The marketing year for the 2021 crop year will run from September 1, 2021 through August 31, 2022. The final 2020-21 national MYA price is estimated at \$4.40 per bushel, which up \$.05 per bushel from June projection. This follows corn MYA prices of \$3.56 per bushel in 2019-20, \$3.61 per bushel in 2018-19, and \$3.36 per bushel in both 2017-18 and 2016-17.

Based on the July 12th WASDE report, USDA is now estimating 2019 U.S. planted soybean acreage at 87.6 million acres, which is an increase of 4.5 million acres from the 2021 soybean acreage, but is still below the record national soybean acreage of 89.2 million acres in 2018. The July 12th report projected a U.S. average soybean yield of 50.8 bushels per acre in 2021, which was unchanged from the June report. Total U.S soybean billion bushels, which production for 2021 is now estimated at just over 4.4 billion bushels, which would be an increase from the U.S. soybean 2021 was reduced from production of 4.13 billion 50.7 bushels per acre in bushels in 2020, but is still the June WASDE report below the record U.S. soybean production of 4.54 billion bushels in 2018.

USDA is projecting total soybean usage for 2021-22 at 4.42 billion bushels, which is slightly below the 4.54 billion bushels of usage expected for 2020-21. The projected decrease in usage for the 2021-22 marketing year is the result of lower levels expected of soybean exports in 2021-22. USDA is now estimating soybean ending stocks at the end of the 2021-22 marketing year to be at 155 million bushels, which would be a slight increase from 135 billion bushels expected for 2020-21, but is well below the large soybean carryover levels in other recent years.

USDA is estimating the national MYA soybean price for the 2021-22 marketing year at \$13.70 per bushel, which is a decrease of \$.15 per bushel from the June report. This compares to an estimated soybean MYA price of \$11.05 per bushel for the 2020-21 marketing year, which ends on August 31, 2021. The final MYA soybean price for 2020-21 compares other final corn and soybean yields MYA price in other recent years of \$8.57 per bushel; by USDA, especially if

bushel in 2018-19, and \$9.33 per bushel for 2017-18.

Corn and soybeans usually gather the most interest in the monthly WASDE reports; however, Wheat grabbed considerable notice in the recently released July 12th WASDE report. Total U.S. wheat production for 2021 was listed at just under 1.75 was down from 1.9 billion bushels in the June report. The estimated average U.S. wheat yield for to 45.8 bushels per acre in the July report, which is a rather large monthto-month adjustment. Spring wheat production for 2021 is projected to decline by 42 percent from 2020 levels, which would be at the lowest production level since 1987-88. Of course, a majority of the Spring wheat is raised in the drought-stricken States of Montana, North and South Dakota. The 2021-22 MYA wheat price from June 1, 2021 through May 31, 2022 is now projected at \$6.60 per bushel, which would be a 30 percent increase from the final 2020-21wheat MYA price of \$5.05 per bushel.

There are still a lot of questions yet to be answered regarding both the supply and demand figures in the July 12th WASDE report. Based on the immediate corn and soybean market reaction following recent WASDE report, it is fairly obvious that weather conditions and crop production potential are currently dominating the marketing decisions of grain traders. Many private analysts feel that the final 2021 U.S. may be over-estimated for 2019-20, \$8.48 per drought conditions continue to expand and worsen in the Northern and Western Corn Belt. Both North and South Dakota have considerable corn and soybean acreage in 2021, and many of those acres are currently being impacted by moderate to severe drought conditions, as well as many crop acres in portions of Western Minnesota. There are also questions with regards to USDA's 2021-22 usage estimates, especially at the projected USDA prices for 2021-22. Higher grain prices normally tend to reduce the amount of corn and soybeans used for feed, processing and exports.

Corn and soybean prices were mainly neutral following the July 12th WASDE report. The overall market direction for "new-crop" corn and soybean prices has remained fairly strong in recent weeks, with day-today market movements being closely linked to daily weather patterns and rainfall amounts. The Chicago Board of Trade (CBOT) prices for December corn futures closed at \$5.56 per bushel on July 15, which was down slightly from \$5.74 per bushel in mid-June, but still well-above the \$4.71 per bushel futures price in mid-March of 2021. A year ago, CBOT December corn futures were trading near \$3.45 per bushel following the WASDE report in July of 2020. By comparison, CBOT December corn futures in mid-July were at \$4.48 per bushel in 2019, \$3.59 per bushel in 2018, \$3.98 per bushel in 2017, and \$3.58 per bushel in

The closing November soybean futures price on July 15 following the WASDE report were \$13.80 per bushel, which is nearly the same as in mid-June and compares to the soybean futures price of \$12.20 per bushel in mid-March. The current CBOT price for November soybean futures compares to "new crop" soybean futures prices in mid-July of \$8.91 per bushel in 2020, \$9.17 per bushel in 2019, \$8.49 per bushel in 2018, \$10.34 per bushel in 2017 and \$10.57 in 2016.

Local forward cash prices for "new crop" 2021 corn have stayed near or above \$5.00 per bushel at many locations in the Upper Midwest in recent weeks, with basis levels remaining much wider than the current cash corn basis in many portions of the region. "New crop" 2021 soybean prices have ranged from \$12.00 to over \$13.00 per bushel across the Upper Midwest in recent weeks, with some processing plants offering over \$13.50 per bushel at times. Farm operators have had several opportunities in recent months to forward price a portion of their expected 2021 corn and soybean crop at profitable levels. One challenge with the very hot, dry weather in 2021, especially in the areas hardest hit by drought conditions, has been to make good estimates for their farm-level corn and soybean production levels for 2021.



The sustainable living experts at Eartheasy recommend utilizing lightcolored mulch during heat waves. Such mulch will reflect the sunlight and help to maintain cooler surface soil conditions. Eartheasy even notes that grass clippings, once they've turned from green to light brown, can make for the perfect mulch to protect plants from the heat. Clippings also are free, making them a costeffective solution.

• Water wisely. The horticultural experts at Yates Gardening note that water only helps plants withstand heat waves if it's applied effectively. If water is only applied in short bursts and not long enough so it can penetrate all the way to the root zone, roots will then stay near the surface. In such instances,

roots will dry out during a heat wave and plants won't make it through the season. Timing also is essential when watering. Eartheasy recommends watering in the morning to avoid heat scald and also ensure as little water is lost to evaporation as possible. When watering during a heat wave, do so by hand rather than through a sprinkler. Hand watering allows gardeners to direct all of the water onto the plants that need it most during a heat wave.

 Let your plants pitch in. When planting new plants, it's important that gardeners recognize it takes time for these plants to establish their roots so they're strong enough to withstand heat waves. In the meantime, strategic planting can help them make it through their first heat waves unscathed. Eartheasy notes that planting by taller, more established plants can provide new plants with shade that can help them survive heat waves. Just make sure new plants can still get the sun they need to thrive.

Heat waves are inevitable and potentially harmful to gardens. Gardeners can help their plants beat the heat in various ways.

Backyard barbecue essentials


• Audio/visual enter-







It's Threshing Bee time in Butterfield

2021 Butterfield Steam & Gas Engine Show | Voss Park, Butterfield, MN | Saturday and Sunday, Aug. 21-22

The Butterfield Threshermen will hold their 54th annual Steam and Gas Engine Show Saturday and Sunday, Aug. 21-22 at Voss Park on the west edge of Butterfield, MN, just off Minnesota Highway 60 in southwest Minnesota. The featured equipment on this year's poster are Cockshutt Tractors and Fairbanks Morse steam engines. There will be models of both on display during the 2021 show.

The antique auto exhibit will feature vintage scooters and mini-bikes as a special attraction. Visitors will enjoy seeing these two-wheeled modes of transportation as well as other vintage cars on display.

The show's many attractions include wood cutting by a sawmill, lathe mill, shingle mill and much more. The Voss Park grove will be loaded with antique gas engines, big and small, not to mention scale models. The steam building houses a permanent display of stationary steam engines. There will be an antique and out-of-field tractor pull held on Friday evening at 5:30.

The pioneer town replicates early Butterfield with a school, general store, church, homestead, grist mill, print shop, saddle shop, livery and more. Each has working displays showing how early Butterfield thrived. Pioneer crafts like spinning, weaving, doll-making and broom-making are on-going, and the many antique collections will delight all.

A feature attraction enjoying its second year is the Construction Corner. Vintage earth moving equipment can be seen operating in the demonstrations

on the south side of the show grounds. People of all ages will enjoy watching this machinery do what it does best.

Continuous tainment on stage, from Friday night through Sunday, will feature outstanding bluegrass bands. The audience can watch in shaded comfort with a variety of foods available on the grounds. Sunday morning the 9 a.m. open air church service will feature some of the bluegrass groups.


