



Yes I am exhausted, its been a rough year and now this election, the most stressful ever! On election night I didn't go to bed until 2:00 a.m. which was dumb because there was no news for another 3 days. I am much too old for this business, besides that the covid virus numbers are soaring both in our country and our county. I hope all of you are being really careful and are staying home as much as possible. I'm getting almost reclusive, staying home is beginning to be the normal for me! Pa Lloyd did head north to go deer hunting for a few days with our son and his family. So far the deer he's seen have been too far away but both the teenage Grandchildren have gotten theirs, Maggie (our dear dog) and I stay home.

Every once in awhile we are hungry for just a plain old hamburger, I like to find a new slant on them once in a while so since I love fried onions I like to make the following recipe:

Fried Onion-burgers

- 1 large onion, peeled, halved and thinly sliced salt and pepper
- 1 # hamburger
- 1 Tablespoon butter
- 1 Tablespoon vegetable oil
- 4-8 slices American cheese (or the cheese of your
 - Mayo, mustard and pickles, for serving
 - 4 hamburger buns, toasted

Combine the onion slices and 1 tsp. salt in a bowl and toss to combine. Transfer the onions to a colander and let sit for 30 minutes, tossing occasionally. Transfer onions to a clean dish towel, gather the edges together and squeeze out as much liquid as you can from the onions. Divide the onions into 4 separate mounds on a rimmed baking sheet. Form the beef into 4 lightly packed balls. Place the balls on top of the onion mounds and flatten the beef firmly (use your palm) so the onion adheres to the beef. The patties should measure 4 inches in diameter. season beef with salt and pepper. Melt the butter with the oil in a 12-inch skillet over medium heat. Using a large spatula transfer the patties to the skillet, onion side down. Cook for 6-8 minutes, until the onions turn a deep golden brown and begin to crisp around the edges. Flip the burgers, then increase the heat to high and cook until well browned on the second side about 2 minutes. Add 1 or 2 slices of cheese to each burger and allow to melt. Add mayo, mustard and pickles to the top buns, then place each burger on the bottom buns. Serve immediately.

TOM PALEN I Love That Flag

Just the other day, my brother Dan and I were going through a storage area of mine. I wanted a couple of things, and I found some things I wasn't looking for, but it was convenient to take

them home while we were there.

One of the items I wanted was an American flag displayed in a triangular wooden case my brother-in-law Gary made. Through the glass front, the properly folded flag shows only the blue canton of white stars. This was the flag that was draped over my dad's casket at his funeral. I'll always remember the military service performed at his graveside by the men of the Veterans of Foreign Wars, VFW Post 775 from Ottumwa, Iowa. I could see it again in my mind.

On a sunny day in

February, my family, relatives, and friends gathered under a blue tent in the cemetery. Father Nick had completed his service. Outside the tent, a line of seven veterans in military dress stood in formation. The leader called out, "Present arms." Simultaneously the soldiers lifted their rifles, cocking them. "Aim." They raised their firearms to a 45% angle above the horizon. "Fire!" All seven men fired their guns, sending a deafening shock of sound echoing across the land. "Aim. Fire!" They fired again. "Aim. Fire!" They fired their third and

final round. "Ceasefire." The leader cried out, and the soldiers lowered their arms. Everyone was silent except for sniffles and crying. My knees were shaking.

From a short distance, the bugler played taps. The solitary brass horn penetrated the air with a sad sound and an emotion that pierced my soul. A group of local pilots flew their airplanes in a low pass above the cemetery, followed by a highspeed jet.

Two military men returned inside the tent. With one on each end,

Wreaths Across America's existing website allow for capabilities fundraising customized pages for Participating Locations and Sponsorship Groups, providing real-time information to donors and volunteers across the country. In addition, the nonprofit has focused efforts on other owned-media channels, including Wreaths Across America Radio, an internet radio station bringing you a unique mix of music, interviews and entertainment designed to uplift the American spirit during these challenging times and to promote our mission to remember, honor and teach about America's veterans.

Expanding on Teach aspect of the mission, WAA's Mobile Education Exhibit hit the road early this summer. This traveling learning experience helps live the mission to remember, honor, and teach. The expanding internal movie theater and interactive learning displays help remember the sacrifices our nation's heroes, honor living veterans and teach future generations about the price of freedom.


