4-H focuses on teen mental health and well-being

The Martin County 4-H Ambassador program is a youth leadership program for youth in grades 7 and up. Over the course of a year, Ambassadors learn new leadership, team-building, and communication skills; complete service learning projects; and teach youth around Martin County about

This year, the Martin County 4-H Ambassadors have decided to focus on teen mental health and well-being. In an effort to help their

peers find healthy ways to cope with the stress, anxiety, and disappointment caused by the pandemic, the 4-H Ambassadors are teaming up with Martin County public health experts to provide a free virtual seminar on Saturday, February 13 from 10 a.m. to 11:30 a.m. for area teens.

"We came up with this idea because ever since COVID has hit, everyone has been locked up in their houses and not able to go places it is causing kids, and

even adults, to be very stressed," remarks Jazlyn Geerdes, Martin County 4-H Ambassador. "We hope the participating teens will take away that even though times can get really difficult, you can make it through this. There are people who are just like you and having the same problems. We're all in this together."

The 4-H Ambassadors have been working with Caroline McCourt, SHIP Coordinator, and Anna Garbers, Behavioral Health Program

Manager, to ensure that expert resources and information are provided. Though experts will be presenters during the seminar, the 4-H Ambassadors will serve as the hosts to ensure that this a youth-led and youth-focused seminar.

As Misty Geerdes, Martin County 4-H Ambassador, explains, "it is a group of teens coming together to figure out how to help themselves and others with mental health."

The seminar will be an opportunity for the participating teens to connect and practice healthy coping mechanisms when it comes to dealing stress and anxiety. The seminar will also provide resources on how to deal with the disappointment and sense of loss that the pandemic has caused. There will be interactive activities and space for open and honest discussions.

The Martin County 4-H Teen Mental Health & Well-Being Seminar will be held on Saturday, February 13 from 10 a.m. to 11:30 a.m. and is open to youth in grades 7-12. The free virtual seminar will include engaging activities, resources, and information as well as open discussion with peers. The seminar will be held on Zoom; a link will be provided upon registration.

FDA and Scholastic release new e-cigarette prevention materials for youths

The Food and Drug Administration (FDA), in collaboration with Scholastic, has released several youth e-cigarette prevention materials for middle and high school students. The latest release includes a student magazine and an accompanying teacher guide that highlight the risks of e-cigarette use and nicotine addiction. Scholastic also launched their "Vaping's Not My Thing" Student Challenge, a contest where students will create a poster, infographic, or annotated illustration to convince other youth of the serious health risks of vaping. Additional Scholastic materials include lesson plans, activity sheets, a guide for parents to talk to their kids about e-cigarettes, and infographics.

Esther was born in



Family farms are recognized as a Century Farm

The farm must be: 1) at least 100 years old according to authentic land records; 2) in continuous family ownership for at least 100 years (continuous residence on the farm is not required); and 3) at least 50 acres and currently be involved in agricultural production.

Research indicates that more than three out of four Americans suffer from varying degrees of glossophobia which includes symptoms like sweating, trembling, and an accelerated heart rate. What is glossophobia? The fear of public speaking!

Yet there are a number of Fairmont High School students who run toward this opportunity instead of away from, as many of us are wont to do. This year, 30+ Fairmont students are on the speech team and will be competing in 14 different categories. Nine of these students are celebrating their senior year: Tabitha Thatcher, Isabell Geiger, Tabitha Willner, Faith Heille, Gracia Heille, Jacalyn Reischl, Weston Lougmiller, Annika Wheeler, and Ameya Komaragiri.

Most of the categories, like dramatic interpretation, storytelling, and poetry, have students using their voices, intonations, and body language to

convey a message others have written. Then there are categories where students do write their own presentations, and they compete in categories like informative speaking, original oratory, great speeches, and creative expression. And then there is extemporaneous speaking, extemporaneous reading, and storytelling, which has the student drawing a topic only minutes before the presentation and preparing a speech on the fly. Definitely a category that heightens glossophobia!

The Fairmont High School speech team coached by Kathleen Walker, Erik Walker, and Michael Taylor has a notable and distinguished record at competitions. Fairmont graduate Sarah Bankson Brima is the only student in the history of the Minnesota state speech tournament to get four state championships in any category, and she received all of them in Informative Speaking from 2008-2011 coached under Roxy and Cliff Janke. Fairmont grad Anagha Komaragiri is one of six students in Minnesota to have won three state speech championships in Informative Speaking from 2014-2016 underneath the coaching of the Jankes and the Walkers respectively. Overall, Fairmont Speech holds 115 medals from that tournament over the years, which puts them at fifth overall in Class A. And in 2019, Fairmont earned its third consecutive Section 2A team championship.

Last year, Tabitha Thatcher and Isabell Geiger, who perform together in duo interpretation, performed at nationals in 2020 and made it to quarterfinals, a significant accomplishment. They were among the top 30 duos in the nation!

For Red Rock Center's Virtual Lunchbox Entertainment on Tuesday, February 9, three of Fairmont's seniors will perform or present from three different speech categories beginning at noon.

Annika Wheeler, a sixyear member of the team who took second in sections in 2019 in storytelling and went to state, will perform her version of a story from the Gutenberg Project collection of folk stories and fables.

Weston Loughmiller, a member of the 2018 state speech team, will be presenting in extemporaneous speaking, a category not for the faint of heart.

Ameya Komaragiri, who recently received the honor of being the 2021 regional Triple A student for excelling in arts, athletics and academics will be performing and informing on "This American War over Facts and Truth" by Ira Glass in the Great Speeches category.

Warming Up

t was cold outside **⊥**when I woke up, a few degrees below zero. I opted to use the percolator to make coffee rather than the drip coffee machine. I filled the stainlesssteel pot to the six-cup line with cold water. I placed the basket on the hollow stem, added three scoops of coffee grounds, and put the perforated cover on top. I lowered the assembly into the water, closed the lid, set the pot on the stove, and turned the knob - Tick, tick, tick, tick, woosh. I adjusted the blue flame below.

Above the percolator, I rubbed my hands together, warming them in the heat rising from the flame. Thinking a fire in the woodstove would sure be nice on such a chilly morning; I went out on the deck to bring in a few logs from the

woodpile.

Wearing my buffalo plaid, flannel pajama pants, a Smokey Bear t-shirt, and my house slippers, I stood where the woodpile should be - but there was no wood. I shivered and recited a children's poem. "Old Mother Hubbard went to the cupboard - but when she got there, the cupboard was bare." That's exactly how I felt. I forgot to restock the small pile we keep close to the door.

I walked to the edge of the deck, staring at the big pile of firewood across the yard. "Why couldn't some of that be up here?" I seriously contemplated trekking over to gather an armload of logs. I looked down at my feet and bare ankles inside my slippers. In subzero weather, running across the snow-covered yard, still in my pajamas, would not have been exemplary of good decision-making skills. It was starting to snow. "I should have worn socks." I shivered and went back into the house.

Back in the kitchen, the coffee was perking with a steady rhythm. There's something about that sound that warms the soul - well, it usually warms the soul. That little excursion out to the deck

I poured a cup of coffee and wrapped my hands around the warm mug. "Oh, that feels good."

The mug warmed my hands, but my body was still cold. I wrapped an afghan from the couch around my shoulders, then stood with my coffee, looking out the bay window. A small red squirrel was in the pale green feeder that looks like an old-fashioned metal porch glider. The critter was sitting on his hind legs; his bushy tail pointed upward. He held and turned sunflower seeds using his front paws as he nibbled through the shell. Once he had the tasty treasure inside, he tossed the empty husk over the railing, and picked up another seed. He amused me: how fast his little jaws moved. I wondered where the little guy goes to stay warm on these bitterly cold nights. Just then, something spooked the squirrel.

He jumped from the porch, scurrying across the top of the snow, to the safety of had me plenty chilled. a woodpile. He must have a nest in there because my dog June goes nuts running around that pile looking for him. "So that's where he stays warm."

I smiled, thinking about commonalities between the squirrel and me. To get through the winter, he has nuts and food stashed all around the yard, where I have piles of firewood stacked all around the yard to get me through the winter.

I looked at my dark, empty woodstove, then at firewood outside. The snow was accumulating on the blue tarp that kept the logs below dry. I scowled, "That squirrel is using my firewood to stay warm while I stand here freezing." It just didn't seem fair. "I sure wish I had some of that wood in here." I rechecked the outside temperature; it was up to one degree above zero. "I don't want it that bad.'

I just wanted a way to get warm. Even June was warm, curled up on the sofa. I had an idea that caused me to

As a boy, Evan Smoak was trained in an off-thebooks operation known as the Orphan Program.



IS IT LOVE OR IS IT JUST VERTIGO

ebruary is usually The month we talk about heart health. A little obvious you might say, and I would agree, so I thought I would look at something I have seen a lot of lately and find an angle to make it work into the month of love. True love can make us dizzy or a little light-headed, so let's go with that!!

If you have experienced dizziness or vertigo, you know how unsettling it can be. If it isn't because you are falling in love, you need to find out why you are feeling that way. Vertigo and dizziness are not exactly the same thing, but most people mix the two. Technically vertigo is the sensation of spinning when you are not moving at all; it's that feeling of moving when you're not. Dizziness is more the feeling of being "off" in your balance or your sense of where you are. For simplicity, we'll just call it vertigo since most people know that term.

There are a number of reasons you can feel these symptoms. Your pends on a complex interplay of your eyes, your ears, and the joints in your upper neck; any one can disturb your sense of balance. If it gets bad enough you literally cannot stand! Some of the more extreme causes are conditions such as Meniere's disease, vestibular neuritis, labyrinthitis, and migraines, but much more commonly they are caused by things that can diagnosed and corrected at any functional medicine office. Let's look at a few.

Low Blood Sugar

Low blood sugar, or hypoglycemia, can give you a sense of lightheadedness or dizziness as your legs become weak and your brain gets low on energy. Blood tests that confirm blood glucose along with HBA1c, insulin, and C-peptide can diagnose the source of this problem. A number of supplements such as berberine and chromium can stabilize blood sugar levels. If this is what is causing your issue, then your diet needs to be looked

are chronically high in sugars, carbs, and processed foods almost guarantee a condition called insulin resistance which can set you up for a fall.

Low Iron

Low iron can also cause the weak, lightheaded sensation due to poor oxygenation, especially in your brain and its balance centers. Low iron can be based on not enough dietary intake, poor absorption (remember when I've talked about leaky gut?), or secondary nutritional issues such as copper deficiency. A highquality iron supplement can readily address this issue. Low quality iron supplements absorb very poorly and are more likely to cause constipation than relief. If you often experience cold hands and feet along with fatigue, then you are quite possibly

looking at an iron deficiency.

Medication Side Effect

Many meds cause dizziness and vertigo. Unfortunately, the answer you will receive in these cases is more meds! It is important to review your medication list and check for side effects. Do not leave this up to your health care provider; calling your pharmacist will probably give you a good answer here.

A particularly important thing to remember is that quite often blood pressure meds can lower your blood pressure too much. If your doctor is pushing your diastolic below 60, you may want to remind them that at a certain point falling and breaking something is a bigger risk than high blood pressure! Typically, there are supplements that can help lower blood pressure naturally.

Cervical Spine Issues

An interesting experiment was performed in which lidocaine was injected into the joints of the upper neck to see what effect that would have on spinal function. Many of the test experienced subjects very serious balance problems. If your upper cervical spine has any alignment issues, then nothing else will help with your dizziness. If you already have a history of neck problems, especially upper neck, see your chiropractor

If you find that dizziness and vertigo are worsened by looking quickly to the right or left, then that is usually a confirmation that your spine is the source

of your problems.

There are many other issues that can cause dizziness, including the one everyone blames balance problems on ear stones (technically called otoliths). While these can definitely create issues, my experience has shown that they are rarely the root cause. A combination of chiropractic, nutrition, and functional medicine is often the best place to start to get relief without risking side effects or poor results.

Then again, you may just be experiencing the side effects of love!

Juncos are gray birds that brighten a gray day. A pine siskin wore the evidence of a correct weather forecast. The proof was a few snowflakes perched on the bird's back. Happiness is in the bag. Sunflower seeds. Chickadees moved to and from the feeders at the rate of the candy on an "I Love Lucy" TV episode, the one where Lucy and Ethel got jobs as candy makers at Kramer's Kandy Kitchen. They worked in the wrapping room assembly line where their task was to wrap every chocolate candy as it went by on a conveyor belt. The speed of the conveyor forced them to eat the candies or stuff the sweets into their hats and blouses.

A friend, Penny Jacobsen of Albert Lea, called to recommend the book, "Braiding Sweetgrass: Indigenous Wisdom, Scientific Knowledge, and the Teachings of Plants" a nonfiction book by Robin Wall Kimmerer and published by Milkweed. It's a wonderful book I'd just started reading not long before her kind

munks hibernate in winter, but they don't through sleep the season. Hibernation means something different to each species. Some call the chipmunk's a torpor. It's a restless hibernation. They retreat to their burrows and wake every few days to raise their body temperatures to normal, feed on stored food rather than fat reserves, and urinate and defecate. Their heart rate declines from about 350 beats per minute to four beats per minute. Body temperature may drop from 94° to the temperature of the burrow - as cold as 40°.

New Year's Day. Chip-

There were five pheasants and four fox squirrels foraging under the feeders. All was calm. Then another fox squirrel dropped from a feeder. Panic ensued. It became the Monty Python skit of the footrace for people with no sense of direction. I recalled a day years before when the house cat was birdwatching from a window holding a feeder attached by suction cups. As the feline watched, a squirrel dropped from the roof in a superhero attempt to find access to the feeder. The weight of the squirrel knocked the feeder from the glass. The cat's eyes grew larger as it turned and looked at me as if to say, "That's why I watch birds."

Eight pheasants became eight lumps in a bent tree in the gathering darkness. Roosting in trees is a predatoravoidance behavior.

My eyes produced tears as I walked into an east wind. The proverb says, "When the wind is in the east, 'tis neither good for man nor beast; when the wind is in the north, the skillful fisher goes not forth; when the wind is in the south, it blows the bait in the fishes' mouth; when the wind is in the west, then 'tis at the very best."

Carol Hegel Lang of Albert Lea, Jill Evans of Mankato and Tim Scott of Mankato all reported wintering Carolina wrens. I recall walking a trail in Columbia, Missouri, lost in my thoughts and delighting in the songs of the Carolina wren that followed

There was a spruce budworm outbreak across large portions of Quebec and Ontario the past several years. Because of the pandemic, areas of Quebec weren't treated with pesticides for budworm. Large sections of the boreal forests produced two excellent spruce cone crops during the last four years. These things led to a finch irruption event. Evening grosbeak, purple finch, and to a lesser extent, pine siskin, are spruce budworm specialists. There are spruce budworm warblers, too — Cape May, Tennessee and bay-breasted.

Q&A

"What can I feed wintering robins?" Place apple slices, raisins, blueberries, grapes, strawberries, cranberries, raspberries, cherries, small bits of suet or mealworms at ground level.

"How many snowy owls have been seen in Minnesota this winter?" As of Jan. 31 there had been 72 observations in 16 counties: Becker,

Kittson, Marshall, Pine, Polk, St. Louis, Benton, Dodge, Hennepin, Lac qui Parle, Le Sueur, Martin, Rice, Stearns, Stevens and Watonwan.

Where do the sandhill cranes from Minnesota go in winter?" Minnesota birds are short-distance grants. Birds in eastern Minnesota migrate southeast to Georgia and Florida; birds in western Minnesota migrate south to the Gulf Coast of Texas.

When are the mating seasons for coyotes and red foxes?" Coyotes mate at age two and may pair for life. The mating season begins in January and lasts through February. Five to seven pups are born in April. Red foxes mate at age one in February and 52 days later five to ten pups are born that are fully independent at seven months.

Avoid Tapping Into 401(k) Early

If you've been contributing for many years to your 401(k) or similar retirement plan, it may be your largest pool of money. So, if you are facing a financial need, you may think about tapping into your account. After all, it's your money - why not use it?

But touching your 401(k) before you retire may not be a good idea, as it can lead to some unwanted consequences.

First, taking funds out of your 401(k) now could increase the risk of running out of money during retirement, which could last for decades.

Also, withdrawals taken from your 401(k) before age 59½ may be taxed as ordinary income and are generally subject to a 10% penalty for early withdrawal, although there are some exceptions. And a sizable taxable withdrawal from your 401(k) could bump you into a higher tax bracket.

Therefore, if you are facing a financial crunch, you may want to explore some options before tapping into your 401(k). For starters, see if you can cut your expenses where possible and explore financial assistance programs that service providers, such as utility companies, might offer.

Also, if you have an emergency fund, now may be the time to use it. For most folks, it's a good idea to keep three to six months' worth of living expenses in such a fund, with the money kept in a liquid, low-risk account. But even smaller amounts can help in a financial crunch.

You might also find another source of cash in your taxable investment accounts. Any uninvested cash in these accounts is an easy place to start. You might also look at selling investments to free up some cash. However, before making this decision, you may want to consult with a financial professional to discuss the pros and cons.

Another cash-generating option is a 401(k) loan, assuming your plan permits such loans. Unlike a direct withdrawal, a 401(k) loan is not taxable if it's repaid on time. (If it isn't, you could also incur penalties.) And, although the loan may have some fees, the interest on it will be paid to your account, rather than to a bank. However, you won't earn investment returns on the loan balance, because you can't use this money to invest. And if you leave your job before you've fully repaid the loan, you'll likely have to come up with the remaining balance quickly.

You could also consider using your credit cards to generate cash, but these types of loans or advances can be quite costly. Instead, you may want to look at other possibilities,

Fortunate to live in Fairmont

I have been fortunate to have lived in Fairmont all my life and I benefited from an excellent public school system with what we then called "shop classes". Those "shop classes" gave me the opportunity to try different areas of work while in school so I could choose the direction I wanted to pursue for a career. Preparing for Cold Weather

Question: What items should I have in my vehicle during this extreme cold weather? What is the proper procedure if I become stranded and/or go off the road?

Answer: With the recent below zero temperatures, being prepared with an emergency kit and plan can save your life.

We recommend the following items be in your vehicle, especially in the winter:

- •Bag of abrasive material (sand, salt, cat litter) or traction mats
 - Snow shovel
 - •Flashlight with extra batteries
 - •Window washer solvent
 - •Ice scraper with brush
 - •Cloth or roll of paper towels
 - •Jumper cables
 - •Tow chain or rope
 - •Extra warm clothing (gloves, hats, scarves)
 - Blankets
 - •Warning devices (flares or triangles)
 - Drinking water
- •Non-perishable snacks for both human and pet passengers
 - First-aid kit
- •Basic toolkit (screwdrivers, pliers, adjustable wrench)

•Mobile phone and car charger pre-programmed with rescue apps and important phone numbers including family and emergency services

If stranded, stay in the vehicle and call 911. Provide the Dispatcher with the following information:

- •Problem you're experiencing
- •Your location (Get in the habit of looking for mile markers and cross streets/roadways)
 - •Any injuries to yourself or passengers

•Preferred tow company, otherwise the closest approved tow company will be dispatched

At night, keep your dome light on and activate the vehicle's emergency flashers.

Be aware that snow can plug your vehicle's exhaust system and cause deadly carbon monoxide gas to enter your car so make sure the exhaust pipe is free of snow and keep a window slightly open while the engine is running.

Make sure your vehicle is properly maintained and that you have at least a half of a tank of fuel.

Slow down and use winter driving skills to avoid crashing or going off the road.

You can avoid a ticket — and a crash — if you simply buckle up, drive at safe speeds, pay attention and of course, drive sober. Help us drive Minnesota Toward Zero Deaths.




