## Oats Threshing at Heritage Acres Sunday

Heritage Acres will hold its annual oats threshing this Sunday, August 9th from 11 a.m. to 4 p.m. This free event will include blacksmithing demonstrations, live music with Steve Lang and Bob Petrowiak from noon to 2 p.m. and old time oat threshing throughout the afternoon. A few vintage tractors will be on display and many of the Heritage Acres buildings will be open.

About two acres of oats were planted in early spring southwest of the Prairieville building. They were cut and bundled with a hundred year old binder, shocked (stacked to dry for a week), then loaded on hay racks that were put under cover.

Before farmers traded in horses for tractors, oats were primarily grown for horse feed.

## **Lighter Summer meals**

Hot weather means simpler meals. Who wants to stand over a hot stove when its so warm outdoors? Not me! We are getting red ripe tomatoes from our very own plants and my basil plants look like little bushes so I am all set for today's recipe! I hope you will enjoy it too.

## Grilled Havarti, tomato & basil sandwiches

1/2 cup Hellmann's mayonnaise 8 slices French bread or country loaf 8 slices Havarti cheese 1 large vine-ripened tomato, cut into 8 thin slices leaves from 1 small bunch of basil, torn

Spread mayo on both sides of each slice of bread. On each of 4 slices bread, layer 1 slice of cheese, 2 tomato slices, a scattering of basil leaves, and another slice of cheese. Place the remaining bread slices on top of each.

Heat a large skillet over medium-high heat until hot. Toast the sandwiches until nicely browned on both sides and the cheese is melted, 4-6 minutes. Flip the sandwiches about halfway through cooking. Reduce the heat to medium if the sandwiches are browning too quickly. Slice each sandwich in half and serve immedi-

Makes 4 servings.



for:

- · Judgment and decision-making skills
- Ability to drive with special devices that adapt your vehicle to your needs

The specialist may recommend ways for you to drive more safely after the evaluation. Suggestions may include getting special equipment for your car or helping you sharpen your skills.






